Calculation of Holiday Pay

From 1st April 2020, the reference period to be used for calculating holiday pay is increased from 12 weeks to 52 weeks. This means that you will be required to average the daily/hourly rate for holiday pay for any employee who receives regular commission, bonus or additional pay (including overtime) over the preceding 52 weeks.

For term time casual employees, the following calculation should be used:

5.6 weeks /number of weeks worked

For example:

Employee A is contracted to work for 32 weeks of the year at an hourly rate of £10.50

The holiday calculation would be:

5.6 weeks/32 = 17.50%

For every hour that Employee A works, they are entitled to (£10.50 @17.5%) + £1.84

Going forward, we will need this information when paying any casual member of staff (Support and Teaching).

Term Time Leavers

We are receiving an increasing number of queries in relation to holiday pay entitlement for term time employees who leave before the end of the academic year. As the annual salary for these individuals and their pro-rated holiday entitlement is calculated at the outset with a presumption that they will work for the entire year (or for a specific period), the calculation can be deemed to be incorrect where this no longer applies.

Many of our schools use calculators provided by their HR, however some do not. As the terms and calculations differ from school to school, we will be happy to provide the final payment due to the employee, if we are equipped with the preferred formula for your school. Can you therefore please discuss this with your normal Baxter Payroll Administrator who will be able to assist you.

Long Term Sickness and Maternity Leave

Employees continue to accrue statutory holiday entitlement during periods of long term sickness and maternity leave. Upon their return (or departure from the school) this payment becomes payable or exchanged for paid holiday leave. Please note that whilst we do not record holiday entitlement/leave taken, we are able to assist you with the relevant calculations upon request.

Online Meetings
